# Arizona 4-H National 4-H Congress Chaperon Position Description



## Requirement for Chaperon

Chaperon must be a Certified 4-H Leader or a County Extension Faculty member. Must have experience with chaperoning youth.

## Responsibilities:

- Provide a safe environment and caring relationship for youth delegates and to represent the Arizona 4-H Youth Development Program appropriately per the Code of Conduct
- Capability to spend the time to serve as an adult chaperon within the framework of the event's activities
- Willing to listen to youth's ideas and provide appropriate guidance.

## Qualifications:

- Strong interest in youth development,
- Able to provide appropriate role model to uphold the Arizona 4-H Code of Conduct.
- Need to be at least 25 year and older to apply
- Minimum of 2 years 4-H volunteer leader experience

## Individual's Commitment:

- Will meet via conference call for trip planning. This would be a minimum of one hour commitment. Able to participate fully in the National 4-H Congress events, from trip departure until arrival home, approximately 5 days.
- Willing to share experiences with others, minimum presentation time. This will occur 2 to 3 times, approximately 1 hour each time.
